The 5K/IOK competitive run will begin at 8:00 am on an asphalt surface with gentle rolls starting at the Versailles High School, going north on Highway 5 before turning south and winding through the city of Versailles and returning to the school (route closed). The 2-mile casual walk will begin at 8:15 am on a scenic path through the high school's outdoor classroom. The ¹/₂ Mile Kids Fun Run will be on the high school track beginning at 9:30 am. NO roller blades or wheeled shoes, please. Parking, changing rooms, and restrooms are available at the Versailles High School.

AWARDS: An overall award will be presented to the first male and female finisher in 5K/10K run. A medal will be given to first place in each age division in the 5K/10K run as well as in the ½ Mile Fun Run. *Award winners must be present to receive their award*.

Age divisions for Male and Female are:

5K/10K Run 14 years and younger, 15-19 years, 20 to 29 years, 30 to 39 years, 40 to 49 years, 50 to 59 years, and 60 years and older. 1/2 M Kids Fun Run 10 years and younger

REGISTRATION: Must register by April 15th to receive a 2014 T-shirt. *Any pre-registered participants not walking or running on race day must make arrangements by May 5, 2014 to pick up their shirts or forfeit them*. All registrations not received by April 15th are not guaranteed a 2014 T-shirt. Entry fee is \$10 for ½ Mile Fun Run, \$25 for other events. Late entry fee (received after April 15th) is \$30 for all events. All proceeds support Citizens for Health and Wellness WHIP program to provide vouchers for primary care or vouchers for Morgan County Health Center's Chronic Disease Management program.
